# Herndon Speech-Language-Hearing Clinic Fort Hays State University

Hays, Kansas



We would like to have you meet a special little boy who comes to the Herndon Clinic. His name is Brodie and he is 3 1/2 years old. His mother brought him to the Herndon Clinic approximately one year ago because she was concerned that Brodie communicated using only sounds, babbling, and gesturing. His mother noted that he has a lot to say but gets easily frustrated when others cannot understand him. She reported that Brodie's overall health and development had been fine and that Brodie is a happy little boy and gets along well with others.

Brodie's evaluation showed him using approximately 5 words as compared to 200-300 words which would be considered average for his age. Services began in late Spring 2013 and continue at this time.

He comes to the clinic twice a week for 30 minute sessions. His goals focus on improving his expressive speech and language.

Brodie's student clinician, Beth, reported that she feels very fortunate to be working with Brodie. She stated "I am learning a new approach which is helping Brodie build on what he can do but also challenging him to develop more advanced skills." Beth also noted that this experience is building her overall clinical skills which is helping her prepare for her first job. She said "I really enjoy working with Brodie and am grateful for the experience!"

Brodie's mother cannot say enough positive things about how the Herndon Clinic has helped her son! She reported that Brodie is saying new words everyday; "It is wonderful to see improvement!" Her advice to other parents is to do what she did; seek services at the Herndon Clinic if you are concerned about your child's communication development. She noted "Everyone is so nice and helpful!" In addition, Brodie's mother said "Thank you for the Scottish Rite scholarship. They're so wonderful to sponsor the clinic in Hays where children of any age can get help.

## Public receives rare invite to Masonic Temple. Scottish Rite opens Ladies Night to the public.

A public event of this type hasn't been held in more than a decade. It offered an opportunity for viewing scenery and costumes that are used in Scottish Rite Reunions at the Masonic Temple.

As the Scottish Rite steps up to take a major role in making sure that this historical building is used to its full potential, we opened our Ladies Night to the public. We used this opportunity to promote the building as well as Scottish Rite, and received a good response from the people in the community.

Each lady was presented with a rose bud as they arrived in the beautifully decorated dinning room for a candle light dinner. After dinner everyone went upstairs to the third floor auditorium for the scenery and costume show.

Donald F. Hamilton, 33°, Secretary and Personal Rep for the S.G.I.G. of Kansas narrated the program. Here are some of the facts that he shared with us: You will see and hear about many of the 104 large scenic drops used on the stage. They depict everything from Jesus' crucifixion, entry into purgatory and the ascension into heaven to dawn breaking and the day passing to sunset in a forest.

Don Hamilton said, "the best way to say it is Scottish Rite Masonry is taught in the form of Grand Opera or Grand Theater. We have scenes and scripts for actors, who wear costumes that depict the story they tell. All the stories depicted are from the Bible."

The scenes were made by the University of Minnesota engineering department around the turn of the century. Each scene, which is accomplished by a backdrop and accompanying pieces that give it depth, is hanging above the stage on its own set of ropes and pulleys, all individually numbered. The scenes are painted with milk based paint on netting.

The scenes were acquired before the Salina Masonic Temple was build in 1927 when the Scottish Rite organization in McAlester, Okla. started construction of a new building with a larger stage. The stage in the Salina building was constructed to fit the scenes or drops, and a Rock

Island railroad car was specially designed with a door in the end to transport the scenery to Salina in the early 1930s. The size of our stage was specifically built to accommodate this scenery, and the rest of the building was designed to fit the stage. We built the stage and then built the building. It's unique from that stand point.

As the scenes were shown members modeled some of the elaborate costumes that are used to help portray the stories that are being told as life lessons.


