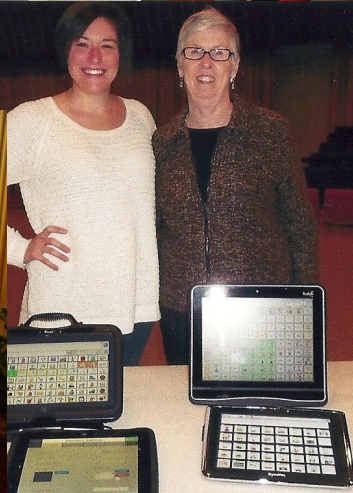

Within Kansas, the Orient of Kansas and Scottish Rite Masons representing seven Scottish Rite organizations, called Valleys, throughout the State provide support and critical funding to maintain five RiteCare® Clinics, located at State universities across Kansas.

Nationally, there are approximately 180 RiteCare® clinics, centers, and special programs operating or planned throughout the United States. Through the support of Scottish Rite members, tens of thousands of youngsters across the United States have received significant help in language and communication skills. Children who might have remained educationally behind for a lifetime can now talk, read, and lead productive lives.

The Ancient and Accepted Scottish Rite of Freemasonry Valleys in Kansas include the: Armed Forces Scottish Center, Ft. Leavenworth; Ft. Greetings from the Evelyn Hendren Cassat Speech-Language-Hearing Clinic. As a RiteCare® Clinic, our semester is off to a good start. The Kaleidoscope Language Development Preschool and Reading Explorers programs serve the needs of young children who are ready to learn. Our social skills groups for children and adolescents with autism spectrum disorder (ASD) are in high demand. We continue to provide individual or small group sessions in the areas language/literacy, speech-sounds, stuttering, and aphasia.

The audiology clinic is growing. We are now providing audiology services to veterans through a contract with TriWest/Blue Cross Blue Shield.

The satellite clinic at St. Francis of Assisi Catholic School continues to provide community outreach services. Four graduate students, per semester, receive clinical training at the facility and serve the speech and language needs of approximately 25 children.

Other community outreach services include the Autism Interdisciplinary Diagnostic Team (AIDT) which includes WSU faculty, clinical educators, students, and community professionals. This team continues to provide identification/diagnostic service for autism spectrum disorders (ASD) to children and families throughout South Central Kansas.

Kathy Johnston, M.S., CCC-SLP has been a clinical instructor in the Hearing & Speech Department at the University of Kansas Medical Center for the past 17 years. Kathy provides pediatric clinical service within our department and also is contracted by KUMC to provide services at The Children's Place, where she works with children who are victims of abuse and neglect. In addition to her teaching and clinical assignments at KUMC, Kathy maintains a private practice in the Kansas City area.

Kathy is a life-long learner. She continually strives to provide the most up-to-date, evidence-based clinical instruction and intervention to her graduate students and her clients and their families. Recently, Kathy became the first person to earn certification in Kansas as an Early Start Denver Model therapist (ESDM) for working with young children with autism. ESDM, which is a comprehensive behavioral intervention for children from 12 to 48 months, defines a curriculum of skills to be taught and the associated teaching procedures to be used to deliver the content. To be ESDM certified, a qualified professional must attend a training workshop and then submit videos that demon-

strate reliable use of the ESDM techniques. Kathy has been selected to be a co-presented on the ESDM certification process at the Kansas Division for Early Childhood state convention in March of this year. She also is beginning to train other community providers on how to use the strategies within the model.

We are proud that Kathy continues to share her knowledge and expertise with our graduate students, as well as clients and families.

There is never a dull moment when spending time around Catie, an imaginative and thoughtful eight year old girl who attends the Herndon Speech-Language-Hearing Clinic. The Herndon Clinic staff, supervisors, and student clinicians began seeing Catie in November 2013 at seven years of age due to concerns with her overall language and reading skills. At that time her parents reported that she has had difficulty with speaking, following directions, writing, and phonological awareness. A comprehensive speech and language evaluation revealed that Catie had a language disorder, characterized by decreased vocabulary, syntax, and basic concepts for her age level. She began receiving services at the Herndon Clinic to improve her overall language and reading skills; more specifically, story comprehension using story grammar elements (e.g., character, setting, feelings, etc.) as well as phonological awareness and early reading skills.

After a year of speech and language therapy, Catie is now able to identify story grammar elements within stories read to her, as well as stories that she creates. She works very hard in sessions in order to

succeed and she continues to make steady progress. She is also able to independently read and write multiple words. She is most consistent with words that are simple consonant-vowel-consonant (CVC) with short vowel sounds (e.g. hop, cat, bet, sit, etc.). She is beginning to read and identify more complex words containing consonant blends (e.g. /br/, /bl/, /cl/, /st/) and digraphs (e.g. /th/, /sh/, /wh/, /ch/). Included










are two examples from one of Catie's recent sessions. The first picture is a visual organizer that Catie used to make a first draft of a story that was read to her. The visual organizer assists Catie with including the appropriate story elements.

At the same time, Catie is also able to practice her spelling skills; on this form, she has completed spelling independently. After completing the visual organizer, Catie makes a final draft with assistance from her fall 2014 clinician, Michele Duryea. At this level, Catie is able to add an illustration for each story element, as seen in the second picture below. Michele provides different levels of assistance with spelling, dependent on Catie's skill level.

Michele has had the opportunity to learn about and practice facilitation strategies with Catie including modeling, recasting, expansions, and verbal feedback. In addition, Michele is able to incorporate learning into interactive tasks such as going on scavenger hunts around the clinic, playing board games, and coloring. Catie has multiple opportunities to use her imagination and share stories with Michele; they have built an extraordinary relationship throughout the semester.

Thanks to the Scottish Rite scholarship, Catie is attending individual speech and language therapy sessions two times a week for an hour. Catie's mother, who is also her home-school teacher, has noted her continued success throughout the past three semesters and is happy to see this improvement. She indicated that the Herndon Clinic is able to offer more specialized skills that have allowed Catie to improve her reading skills.

Catie's mother is grateful that she can bring Catie to the Herndon Clinic for therapy and stated, "Catie would not overcome this wall without help." Her mom further stated that she is thankful to the Scottish Rite Organization for the scholarship Catie receives. The financial support "has been a blessing for our family. We couldn't afford it without their help."

Highlighted Practitioners

After earning both my Bachelor's and Master's degrees from Fort Hays State University (FHSU), Jacque Jacobs joined the faculty at Fort Hays State University (FHSU) during the summer of 2007 as a Program Specialist. Jacque's clinical teaching has focused on adult neurogenic communication disorders and augmentative alternative communication (AAC). In July 2014, she was appointed the Clinical Coordinator for the department.

Jacque notes that her first eight months as clinical coordinator have been a challenging, yet, an exciting learning experience. We are well into the spring semester at the Herndon Speech-Language-Hearing Clinic. The Herndon Clinic offers clinical services for adults and children with speech, language, hearing, and swallowing disorders throughout Hays and

the surrounding area both on campus and off campus. In the clinic, we continue to serve many children with developmental delays, speech sound disorders, language and reading disorders, fluency disorders, autism, and English language learners. Our adult clientele is comprised of those with developmental disabilities, voice disorders, neurogenic communication disorders, and fluency disorders.

During the fall 2014, the clinical services expanded to sites outside the Herndon Clinic. A partnership with Lincoln Elementary School in Hays, KS was established. Clinicians provided weekly small group activities that target phonological awareness (i.e., rhyming, blending and segmenting sounds, etc.) and pre-literacy skills to Kindergartners. The classroom teachers divided their students into small groups; clinicians collaborated with a co-clinician to plan interactive and educational activities that were implemented weekly. The classroom teachers have been pleased with the progress

their students have made with these skills and are looking forward to continuing this partnership in the future.

Also new during the fall 2014 semester was the addition of Sacred Heart Elementary School in Plainville, KS as a clinical setting for our students. Clinicians had the opportunity to go into the classrooms and work with 2nd and 3rd graders on creating summaries for the expository and narrative texts they were reading in class. Other clinicians used the *Supporting Knowledge in Language and Literacy* (SKILL) program to teach the 1st grade classroom about the parts of a narrative and to help them create their own narratives. In addition, graduate students worked with students in small groups and individually who had various speech sound production errors.

Finally, through a contractual agreement with the Southwest Kansas Area Cooperative District, the department hired a full-time faculty member to provide telepractice speech-language services to children in Kismet-Plains, KS. Students have been observing as well as assisting in the implementation of intervention and administration of assessments. We hope to continue and expand this experience in the future.

The Herndon Speech-Language-Hearing Clinic along with the FHSU National Student Speech-Language-Hearing Association will host the third Annual Run/Walk to Help Children Talk on April 25th, 2015 with some exciting new additions. A post-race celebration lunch will be provided and participants will have the option to sign up for a 5K, 1-mile walk, or for the lunch alone. The Run/Walk Committee predicts this will increase overall participation, including participation from supporters who choose not to run or walk. Breanna Taylor joined the FHSU faculty in fall 2013 as a clinical supervisor and is now the assistant clinical coordinator at the FHSU Herndon Clinic. She received her bachelor's and master's degree at Wichita State University. Before joining the FHSU faculty, Breanna worked primarily in outpatient pediatric clinics with children on the autism spectrum, early language development, and augmentative/alternative communication.

At FHSU, Breanna has supervised summer pre-school and school age groups for children to increase language, literacy, play, and social skills utilizing components of the *Early Literacy in Action Program*, by Betty Bunce (Kansas University). Because of valuable information learned in a session at the 2014 RiteCare Conference, Breanna hopes to add a toddler language group in the summer of 2015. Currently, Breanna is leading a *Hanen More Than Words Program* with two graduate clinicians. The Program was designed for children with Autism Spectrum Disorder and/or social communication deficits and provides parents with the tools, strategies and support they need to help their children reach their full communication potential. Thanks to the support of the Scottish Rite Masons, the cost of summer groups

and the specialized programs such as Hanen can be offered at a reasonable cost that local families can afford!

Due to the generous support of the Scottish Rite Masons and the hard work of the creator and former clinic coordinator, Marla Staab, the Run/Walk to Help Children Talk will be hosting its third annual event! Breanna is now the coordinator of the Run/Walk and established a committee of faculty and students to help plan this year's event. A *Post Race Celebration* including lunch and prizes has been added to the itinerary to provide a family friendly event that all members of the community can attend. All proceeds from the Run/Walk will go towards client scholarships and much needed clinic materials.

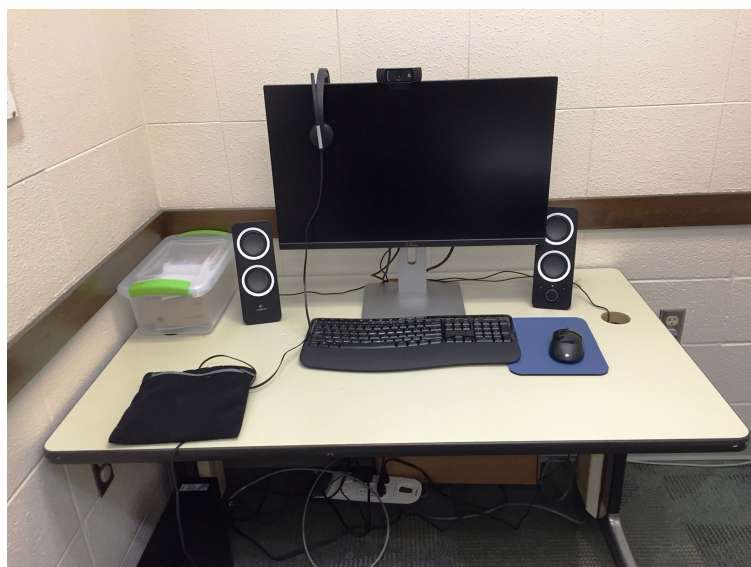

Telepractice Pilot Project

Though our services keep us busy, it has not stopped us from initiating a new project – our telepractice pilot. We are fortunate to have Alli Meder, a Ph.D. student in speech-language pathology, to coordinate our new endeavor. Telepractice is the use of technology to deliver speech language pathology and audiology services at a distance. Telepractice enables speech-language pathologists and audiologists to provide services to individuals who are unable to come into a clinic. It also enables school districts who cannot find a speech-language pathologist to hire to provide services from a distance. We believe that telepractice is something that will be used with more frequency and that it can positively affect the work that we do. Because we have not provided telepractice before, we are beginning slowly with a pilot project. We will begin in mid-April by providing telepractice services to 3 children who come to the Schiefelbusch Clinic for services once a week but who could benefit from more frequent services. We will also provide services to 3 students in the Oskaloosa Elementary School. Starting small will allow us to work through the inevitable “glitches” that will occur. We are excited about the possibility of expanding our pilot to reach children who would otherwise not be able to receive services, to improve services to children who are receiving some service but need more, and the opportunity to train students to provide services at a distance. This project would not be possible without the support of the Topeka Valley and the Kansas Scottish Rite Foundation. Thank you!

Her services have been at home, in school, and in the Clinic. 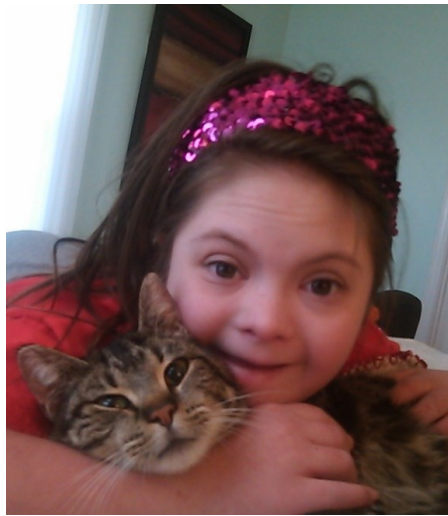

Enthusiastic speech pathologists' provided family educational training and speech therapy with innovative tools, which drew her siblings to participate in her therapy sessions. The Schiefelbusch Clinic and the Scottish Rite Scholarship program have been a consistent bond and huge source of family support! They provide consistent therapy sessions in clinic and out of clinic, support in public school transitions between teachers, para professionals, grades, schools, and consistent support during life events. Schiefelbusch Clinic students and faculty have helped provide communication tools and advocated on Faith's behalf each year at IEP meetings. So important to Faith's progress in speech and communication are

portant to her ability to access the curriculum and partake in society. For example, her interest in learning and her discipline to sit and attend in clinic transferred to her ability to now play the piano without key labels, memorize cheers as a cheerleader in seventh grade, attend to her coursework, read independently, and attend social events. Faith's improving speech and language enable more individuals to understand her. The Schiefelbusch Clinic with support from the Scottish Rite Foundation scholarship program has provided encouragement and support beyond Faith's speech and communication to increase family bonding and to create social independence, which positively affects her whole world.
